
ASSIGNMENT

ASSIGNOR shall, when requested by ASSIGNEE, execute all rightful oaths, assignments, and powers of attorney, including but not limited to the right to file and prosecute in its own name, wherever so permitted by law, patent applications, including corresponding applications outside of the U.S., and to claim priority of patent applications pursuant to the Paris Convention, to ASSIGNEE and to agents and legal representatives of ASSIGNEE, and all other papers necessary and proper to carry out the intent and purpose of this Invention Assignment.
