## ASSIGNMENT

Abdullah Moraizeeg Al-Harbi, residing at Alqaswa--5128, Al-Madinah, 42391-7312, Saudi Arabia ("Assignor") has made an invention(s) (the "Invention(s)") set forth in a patent issued in the United States, entitled DEVICE AND METHOD FOR STRIPPING LEAVES FROM HERBS AND PLANTS, bearing US Patent Number 7,909,687 (the "Patent")

NOW, THEREFORE, for good and sufficient consideration, the receipt of which is hereby acknowledged, and to the extent that the Assignor has not done so already via a prior agreement with the Assignee, or if the Assignor has already done so via a prior agreement with the Assignee then in confirmation of any obligation to do so in said prior agreement, the Assignor has sold, assigned, transferred, and set over, and by these presents does sell, assign, transfer, and set over, unto the Assignee, its successors, legal representatives, and assigns, the Assignor's entire right, title, and interest in:

- (a) the Invention, but not in Saudi Arabia, United Arab Emirates, Qatar, Kuwait, Bahrain and Oman;
- (b) the Patent;
- (c) the right to file applications for patent of the United States or other countries, but excluding Saudi Arabia, United Arab Emirates, Qatar, Kuwait, Bahrain and Oman, on the Invention, including all rights under the Paris Convention for the Protection of Industrial Property and under the Patent Cooperation Treaty;
- (d) any patent or application for patent of the United States or other countries, but excluding Saudi Arabia, United Arab Emirates, Qatar, Kuwait, Bahrain and Oman, claiming priority to, or from, such applications in preceding paragraph (c) or the Patent;

(e) any applications for patent, but not in Saudi Arabia, United Arab Emirates, Qatar, Kuwait, Bahrain and Oman, claiming the Invention, including any divisions, continuations, and continuations-in-part; and

(f) any provisional or other right to recover damages, including royalties, for prior infringements of any application for patent or patent identified in the preceding paragraphs (b)-(e); and

(g) any patents of the United States or other countries, but excluding Saudi Arabia, United Arab Emirates, Qatar, Kuwait, Bahrain and Oman, that may be granted for or on any application for patent identified in the preceding paragraphs (b)-(e), including any reissues and extensions of said patents.

The above-granted rights, titles, and interests are to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor had this sale and assignment not been made.


Except for rights in Saudi Arabia, United Arab Emirates, Qatar, Kuwait, Bahrain and Oman, which Assignor does not assign to Assignee hereunder, the Assignor hereby represents to the Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, or if applicable, at such time said prior agreement was executed, the Assignor is a lawful owner of an undivided interest in the entire right, title, and interest in and to the Invention(s), that the Invention(s) are unencumbered, except, if applicable, by obligation to assign in accordance with said prior agreement, and that the Assignor has good and full right and lawful authority to sell and convey the same in the manner set forth herein.

The Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns, that the Assignor will sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done in connection with any and all proceedings for the procurement, maintenance, enforcement and defense of the Invention(s), said applications, and said patents, including interference proceedings, without charge to the Assignor, its successors, legal representatives, and assigns, but at the cost and expense of the Assignee, its successors, legal representatives, and assigns.

The Assignor hereby authorizes and requests the attorneys appointed by Assignee to insert in the spaces provided above the attorney docket number of the Patent when known.


