ASSIGNMENT

WHEREAS, R. 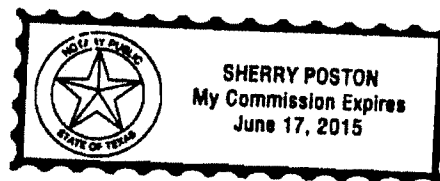
