We, Jun Shi of 302 Kinne Road, Glastonbury, CT 06033, David C. Jarmon of 44 Blue Ridge Road, Kensington, CT 06037, Lee A. Hoffman of 8 Marjorie Lane, Vernon, CT 06066, David J. Butler of 105 Garth Road, Manchester, CT 06040, have invented certain improvements in a "Reverse Flow Combustor Duct Attachment", and described in US Patent Application No. 13/167,167, filed June 23, 2011 and listing as inventors: Jun Shi, David C. Jarmon, Lee A. Hoffman, David J. Bombara, Shaoluo L. Butler, Aleksandar Kojovic, and Lev A. Prociw (hereinafter the Application).

all such rights relating to prior infringements, retroactive or past royalties, provisional rights, and other retroactive or past relief or compensation.

The undersigned hereby authorize and request the issuing authorities in all countries and jurisdictions to issue all patents on all said applications to Assignee or its successors and assigns.

The undersigned further agree, without any further payment or compensation by Assignee
