NUNC PRO TUNC ASSIGNMENT OF PATENT

WHEREAS, **WILLIAM H. ASSIGNOR does hereby covenant and agree that he will execute and deliver to said ASSIGNEE any and all additional papers that may be requested by said ASSIGNEE to fully carry out the terms of this assignment.

And ASSIGNOR does hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to the application aforesaid, or for said invention, to said ASSIGNEE, its successors and assigns, in accordance with this assignment.


