## NUNC PRO TUNC ASSIGNMENT OF PATENT

WHEREAS, **WILLIAM H. PORTER** (hereinafter referred to as "ASSIGNOR") invented and owned at the time of his death certain new and useful improvements in **FABRIC COVERED STRUCTURE AND METHOD OF ASSEMBLY OF SUCH STRUCTURE**, for which a United States patent application was filed on the 3<sup>rd</sup> day of December, 2002, as United States Application No. 10/308,561, and for which Letters Patent of the United States issued on the 5<sup>th</sup> day of April, 2005, as United States Letters Patent No. 6,874,518; and

ASSIGNOR does hereby covenant and agree that he will execute and deliver to said ASSIGNEE any and all additional papers that may be requested by said ASSIGNEE to fully carry out the terms of this assignment.

And ASSIGNOR does hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to the application aforesaid, or for said invention, to said ASSIGNEE, its successors and assigns, in accordance with this assignment.
