
ASSIGNMENT



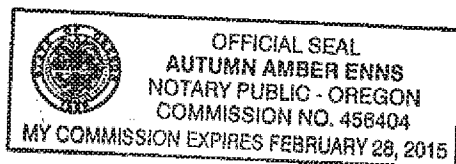
