ASSIGNMENT OF PATENT RIGHTS

This Assignment of Patent Rights, effective as of February 1, 2012, is made by Thomson Licensing, a French company having an address at 1 rue Jeanne d'Arc, 92443 Issy les Moulineaux Cedex, France (formerly located 46 Quai A. NOW, THEREFORE, pursuant to certain obligations owed to Assignee and for good and valuable consideration already received, Assignor does hereby confirm that is has sold and to the extent such prior transfer was ineffective or incomplete does hereby sell, assign, and convey, unto Assignee, its successors and assigns, its entire right, title, and interest in and to said patent applications, including any continuations or divisionals thereof (collectively the "Patent Applications"), and any patents that issue from such applications, continuations, or divisionals (collectively the "Patents"). The rights transferred to Assignee include, but are not limited to:

1. the right (but not the obligation) to sue for, and collect, all claims for damages by reason of infringement of any such Patents (occurring on or after the effective date), or any reissues, re-examinations, renewals, or extensions of such Patents as may be granted; and

Assignor agrees to execute or procure any further necessary assurances of title and will execute all further instruments and perform all acts upon the request of the Assignor and at the expense of Assignor, which may be necessary to carry this agreement into full effect. This agreement shall bind Assignor, its legal representatives, successors, and assigns.

The Commissioner of Patents is hereby authorized and requested to issue any and all Patents of the United States to the Assignee.
