

This intra-TRADECO Group action also terminates the previous patents licenses of US Patent Nos. 6,073,138 and 6,324,541, by BoardWalk Ltd to TRADECO Aerospace Ltd, as hereafter, until advised to the contrary, TRADECO Aerospace Ltd will be the sole owner of these patents as well as the Dutch patent of 1998.

On the basis of my full power as Group Chairman, I declare that these actions and transfers are merely intra-TRADECO Group operations not subject to any authority outside of the TRADECO Group of Companies.
