for which an application for a United States Patent is to be filed, and

NOW, THEREFORE, this indenture witnesseth that for and in consideration of the sum of ten dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR, the inventor(s), has sold, assigned, transferred and set over and does hereby sell, assign, transfer and set over to the ASSIGNEE 25% ownership interest in the invention and application, and any and all divisions and continuations thereof, and any and all Letters Patent of the United States, its territorial possessions, and any and all foreign countries which may be granted therefore, and any and all reissues of the Letters Patent, including the subject matter of



any and all claims which may be obtained in every such patent, the same to be held and enjoyed by the ASSIGNEE for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which the Letters Patent of the United States, territories and foreign countries are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment and sale had not been made.

AND, ASSIGNOR hereby authorizes and requests the Commissioner of Patents to issue any and all Letters Patent of the United States on the invention, or resulting from the application, and from any and all divisions and continuations thereof to the ASSIGNEE, of the 25% interest jointly with the owner of the remaining 75% ownership interest, and hereby covenants that he/she/they has full right to convey the 25% interest therein assigned, and that he/she/they have not executed and will not execute any agreement in conflict therewith.
