WHEREAS:

- (a) The Assignor is entitled to the invention and all rights therein, including the right to be granted a patent, and the entire priority right derived from the application describing the invention, the subject of U.S. Patent Application No. 13/331,212, filed on December 20, 2011, entitled "Rockable Biocontainer" (hereinafter "the invention")

- (c) the said PALL CORPORATION has required the Assignor to make the Assignment hereinafter contained
