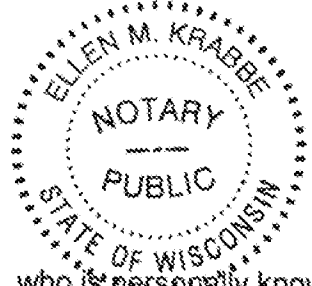
will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to fully carry out the terms of this Assignment.

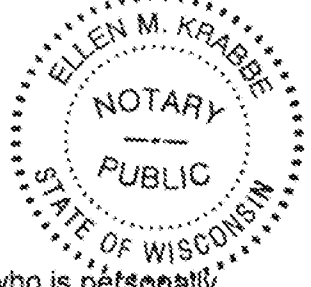

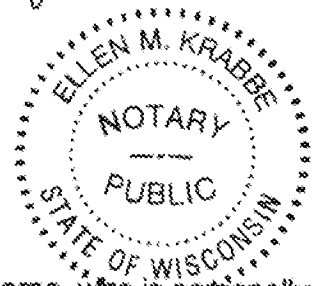

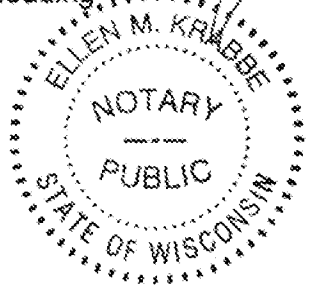
