TERMINATION OF SECURITY INTEREST IN PATENTS

This **TERMINATION OF SECURITY INTEREST IN PATENTS**, dated as of February 29, 2012, is made by THE BANK OF NEW YORK MELLON, in its capacity as agent for the Lenders (the "Agent").

WHEREAS, Latrobe Steel Company (n/k/a Latrobe Specialty Metals Company), a Pennsylvania corporation ("Debtor") has granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain patents and patent applications, pursuant to that certain Patent Security Agreement dated as of July 30, 2010.

WHEREAS, the security interests granted to the Agent were recorded at the United States Patent and Trademark Office as follows: on August 2, 2010 at Reel 024776 and Frame 0127; and

WHEREAS, the Agent has agreed to terminate and release its security interest in all of such Patents, including, without limitation, the Patents identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the Agent hereby terminates and releases all mortgages, liens, and security interests granted to the Agent in the following: (a) all of Debtor's now existing or hereafter acquired right, title and interest in and to all of Debtor's interest in any patents and all applications, registrations and recordings relating to the foregoing as may at any time be filed in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, any political subdivision thereof or in any other country, including, without limitation, those patents, applications, registrations and recordings described in Exhibit A hereto, together with all rights and privileges arising under applicable law with respect to Debtor's use of any patents and all reissues, divisions, continuations, extensions and renewals thereof (all of the foregoing being collectively referred to herein as the "Patents"); (b) all present and future inventions and improvements described and claimed therein; (c) all income, fees, royalties and other payments at any time due or payable with respect thereto; (d) the right to sue for past, present and future infringements thereof; (e) all rights corresponding thereto throughout the world; and (f) any and all other proceeds of any of the foregoing, including, without limitation, all damages and payments or claims by Debtor against third parties for past or future infringement of the Patents.
