ASSIGNMENT

Seller agrees that, without further consideration, Seller and Seller's successors, assigns and legal representatives will cooperate with Buyer, its successors and assigns in the prosecution of all such inventions, improvements, patents and patent applications, including the patents and patent

applications listed on the attached "Schedule A," will execute, verify, acknowledge and deliver all such further papers, including applications for patents and for reissues and extensions therefor, and instruments of assignment and transfer thereof, to vest and confirm in Buyer, its successors and assigns, the legal title in and to such inventions, patents and patent applications, and will communicate to Buyer, its successors and assigns any facts known to Seller relating to the inventions disclosed in the patents and patent applications listed on the attached "Schedule A" to obtain or maintain or enforce patents for inventions disclosed in the patents and patent applications listed on the attached "Schedule A" and improvements therein in any and all countries and to vest title thereto in Buyer. Seller further agrees that such Seller will, without further compensation to Seller, perform such other acts as may be reasonably required when requested by Buyer, including preparing and executing declarations and affidavits to obtain or maintain or enforce patents and patent applications for the inventions disclosed in the patents and patent applications listed on the attached "Schedule A" and improvements therein in any and all countries and to vest title thereto Buyer.

Seller does hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and the equivalent authority in each other country and patent region in the world, to issue such Letters Patent as shall be granted upon said inventions or applications based thereon to Buyer, its successors and assigns.
