RECITALS

- A. The Designer is the author of the Design in respect of which the Design Application was filed.
- B. The Designer assigned his entire right, title and interest throughout the Territory in, and to, the Design, the Design Application and copyright in the Design to N-Zone in the Assignment, including the right to claim Convention priority from the Design Application.
- C. N-Zone assigned its entire right, title and interest throughout the Territory in, and to, the Design, the Design Application and copyright in the Design to Jet Black in the Assignment, including the right to claim Convention priority from the Design Application.
- D. A Convention Application for registration of the Design in the United States and claiming Convention priority from the Design Application was subsequently filed.
- E. The Design Application proceeded to registration in Australia.
- F. By this document the Designer and N-Zone wish to acknowledge and confirm the Assignment and the ownership of the Design Registration and the Convention Application by Jet Black.

**OPERATIVE PROVISIONS****1. INTERPRETATION****1.1 Definitions**

The following definitions apply to this document.

**Assignment** means the assignment dated 22 April 2010 respectively executed by the Designer, N-Zone and Jet Black.

**Convention Application** means United States Design Application No. 29/368,993 filed on 31 August 2010 claiming Convention priority from the Design Application.

**Design** means the design in relation to which the Design Application was filed.

**Design Application** means Australian Design Application No. 10683/2010 titled "Fluid chamber head of a bicycle fluid resistance trainer unit", filed on 1 March 2010.

**Design Registration** means Australian Design Registration No. 331005 which issued on the Design Application.

**Territory** means the Commonwealth of Australia and all other countries and jurisdictions throughout the world.

**2. CONFIRMATION**

The Designer and N-Zone hereby acknowledge and confirm that Jet Black is the beneficial owner of the entire right, title and interest in, and to, the Design Registration and the Convention Application, and further, that Jet Black is the beneficial owner of the entire right, title and interest throughout the Territory in, and to, the Design and copyright in the Design, by virtue of the Assignment.

**3. GENERAL****3.1 Governing law**

- (a) This document is governed by the law in force in New South Wales, Australia.
- (b) Each Party submits to the non-exclusive jurisdiction of the courts exercising jurisdiction in New South Wales, Australia, and any court that may hear appeals from any of those courts, for any proceedings in connection with this document, and waives any right it might have to claim that those courts are an inconvenient forum.
