**AND** the Assignors hereby agree, upon request, and without further consideration, but at the expense of the Assignee, to communicate to the Assignee or its representatives or nominees any facts known to them respecting the design and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths and generally aid the Assignee, its successors, assigns, and nominees to obtain and enforce proper design protection for the design in all countries, and the Assignors further agree to execute any and all further papers which may be necessary or desirable to vest or perfect the title of the Assignee, its successors and assigns, in and to the invention, and in and to any and all design registrations, or reissues, substitutions or prolongations thereof, which may be granted for the design in any and all countries in the world;

**AND** the Assignors hereby authorize and request any official whose duty it is to issue design registrations to issue each and every design registration to be granted for the design in any and

all countries, and each and every reissue, substitution or prolongation of such design registration, to the Assignee, its successors and assigns;

AND the Assignors hereby authorize the firm of SMART & BIGGAR whose full post office address is 1000 De La Gauchetière West, Suite 3300, Montreal, Quebec, H3B 4W5, CANADA to correct clerical errors in the Assignment or to insert any further identification or other information necessary or desirable to make the Assignment suitable for recordal at the United States Patent and Trademark Office;


