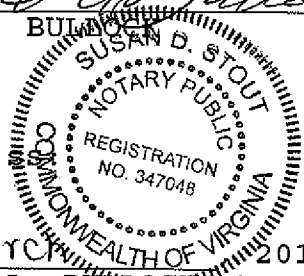
ASSIGNMENT
