WHEREAS, We, Dean C. Webster, a United States citizen, residing at 2434 Parkview Drive, Fargo, North Dakota 58103, United States of America; and Zhigang Chen, a citizen of China, residing at 111C University Village, Fargo, North Dakota 58102, United States of America, have invented certain new and useful improvements in POLYOL PHOTOSENSITIZERS, CARRIER GAS UV LASER ABLATION SENSITIZERS, AND OTHER ADDITIVES AND METHODS FOR MAKING AND USING SAME (RFT-174/178), for which We have filed an International Application under the Patent Cooperation Treaty in the United States Receiving Office, filed as International Application No. PCT/US07/009687 on April 21, 2007;

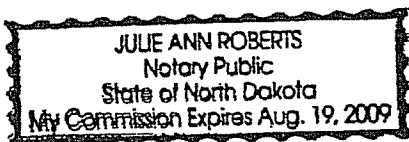

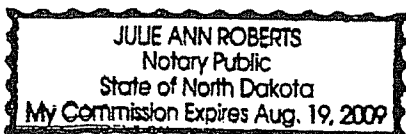
