

DECISION ON RENEWED
PETITION UNDER
37 CFR 1.47(b)

This decision is issued in response to the "Renewed Petition Under 37 CFR 1.47(b)" filed 24 February 2009. No additional petition fee is required.

BACKGROUND

The procedural background for the present application was set forth in the decision mailed 24 November 2008. The decision dismissed without prejudice the petition under 37 CFR 1.47(b) for failure to satisfy all the requirements of a grantable petition. Specifically, petitioner had not provided an acceptable showing that the 37 CFR 1.47(b) applicant Eastland Medical Systems, Ltd. (Eastland) had the necessary proprietary interest in the present application.

On 24 February 2009, petitioner filed the renewed petition considered herein (with required one-month extension fee).

DISCUSSION

The renewed petition is accompanied by supplemental materials, including an executed copy of the previously filed legal memorandum from the Australian legal firm Tait & Co. The present submission, in combination with the previously filed materials, provides an acceptable showing that Eastland has the required proprietary interest in the present application. Petitioner has therefore satisfied the final requirement for a grantable petition under 37 CFR 1.47(b).

CONCLUSION

The renewed petition under 37 CFR 1.47(b) is **GRANTED**. The application is accepted without the signature of non-signing inventor Phillip BUNCE.

A notice of the acceptance of the application under 37 CFR 1.47(b) will be published in the Official Gazette, and a letter informing the non-signing inventor of the application will be forwarded to the inventor's last-known address, as set forth in the petition.
