A S S I G N M E N T

WHEREAS, we, Chris Alan EVERLINE, residing at Quincy, Michigan and Drew H. LARSEN, residing at Ocala, Florida, have invented new and useful improvements in BRAKE SYSTEM INCLUDING MODULAR S-CAM BUSHINGS for which we are about to make application for Letters Patent of the United States, said application having been executed on the 1st and 5th day of March 2012; and


States and its territorial possessions and in any and all foreign countries and in and to any and all divisions, reissues, continuations and extensions thereof.
