

We hereby authorize and request the Patent and Trademark Office officials in the United States of America to issue any and all of said patents, when granted to said Zeppelin Systems GmbH, as the assignee of our entire right, title and interest in and to the same for the sole use and enjoyment of said Zeppelin Systems GmbH, its successors and assigns.


Further, we agree to execute all papers and to give such lawful testimony and to perform such other lawful acts as said Zeppelin Systems GmbH, its successors and assigns
