Paradyne Corporation ("Paradyne") and Bank of America, N.A. (successor to BankAmerica Business Credit, Inc.), ("Lender") entered into a Loan and Security Agreement dated July 31, 1996 (also referred to as the "Credit Agreement"), wherein Paradyne granted Lender a first priority security interest in certain assets of Paradyne, including but not limited to, patents and trademarks held and to be held by Paradyne.

By this letter, the Lender hereby agrees, acknowledges, and confirms the following: (a) that Paradyne has fulfilled all of its obligations under and is not in default in connection with the aforementioned Agreements, (b) that the aforementioned Agreements have been and are terminated, (c) that the patent and trademark security interest (s) is and has been terminated, released and expired, and (d) that the Lender no longer holds any security interest whatsoever in connection with such Agreements in any of said assets defined in the Credit Agreement, including but not limited to, the patents and trademarks held or to be held by Paradyne in the past, present, or future.

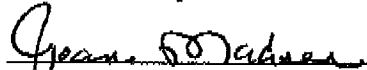
