AND EACH ASSIGNOR HEREBY covenants that each such ASSIGNOR has the full right to convey the interest herein assigned by such ASSIGNOR, and that such ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;

AND EACH ASSIGNOR HEREBY further covenants and agree that such ASSIGNOR will communicate to ASSIGNEE any facts known to such ASSIGNOR respecting said improvements and applications, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally provide

reasonable aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.
