ASSIGNMENT

WHEREAS, **Anup D. Karnalkar**, a citizen of the United States, residing at Allen, TX, **R. Tyler Wallis**, a citizen of the United States, residing at Dallas, TX, **William S. Robbins**, a citizen of the United States, residing at Sun Prairie, WI, and **Susan S. Steele**, a citizen of the United States, residing at Alpharetta, GA, hereinafter called the "Assignors", have made the invention described in the United States Patent Application entitled "**SYSTEM AND APPARATUS FOR MANAGING TASKS**" Attorney Docket No. 7785-369 (AT&T 2008-1173), for a full description of which reference is here made to an application for Letters Patent of the United States filed on herewith and,

AND said Assignors hereby covenant and agree, for both the Assignors and the Assignors' legal representatives, that the Assignors will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignors will execute and deliver to the Assignee to carry out the terms of this Assignment. Assignors authorize attorney or agent to fill in the U.S. Application Serial No. above, if required.

AND said Assignors authorize and request the Commissioner of Patents to issue Letters Patent on said application, and on any all divisions and continuations thereof, to said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.

The ASSIGNORS hereby appoint registered patent practitioners associated with the patent application identified above as my representatives with full power of substitution and revocation to prosecute this application and to transact all business in the Patent and Trademark Office connected therewith, to amend the specification, to appeal in case of rejection, as may be deemed advisable, to receive the patent when granted and generally to do all matters and things needful and additionally to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.

This Assignment may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original, and such counterparts together shall constitute one and the same instrument. A facsimile copy of this Assignment, including the signature pages hereto, shall be deemed to be an original.






