## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made and effective as of the date indicated below and is granted by **SUNTRUST BANK**, in its capacity as Lender ("Releasor"), in favor of **CHRISTOPHER J. VITITO**, a Florida resident ("Releasee").

WHEREAS, Releasor entered into that certain Revolving Credit and Term Loan Agreement dated as of August 22, 2006 by and among CVMA GROUP HOLDINGS, INC., a Florida corporation, VIDEO HEADREST SYSTEMS, L.L.C., a Florida limited liability company, VITITO INTELLECTUAL PROPERTIES, L.L.C., a Florida limited liability company, and INVISION INDUSTRIES, INC., a Florida corporation (collectively, the "Borrowers") and Releasor (including all annexes, exhibits and schedules thereto, and from time to time as amended, restated, supplemented or otherwise modified, the "Credit Agreement"); and

WHEREAS, in order to induce Releasor to enter into the Credit Agreement and the other Loan Documents and to induce Releasor to make the Loans as provided for in the Credit Agreement, Releasee agreed to grant a continuing Lien on the Intellectual Property Collateral (as hereinafter defined) to secure the obligations of Borrowers; and

WHEREAS, Releasor and Borrowers entered into that certain Security Agreement dated as of August 22, 2006 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Releasor and Releasee entered into that certain Intellectual Property Security Agreement dated as of August 22, 2006 (as amended or otherwise modified from time to time, the "IP Security Agreement"); and

WHEREAS, pursuant to the IP Security Agreement, Releasee executed that certain Notice of Grant of Security Interest in Patents dated as of August 22, 2006 and that certain Notice of Security Interest in Trademarks dated as of August 22, 2006;

WHEREAS, pursuant to the Security Agreement and IP Security Agreement, Releasee granted to Releasor a continuing first priority security interest (the "Security Interest") in all of Releasee's right, title and interest in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreement) including without limitation the following:

- (a) all Patents and Patent Licenses to which Releasee is a party, including those referred to on Schedule I hereto;
- (b) all of Releasee's Trademarks and Trademark Licenses to which it is a party, including those referred to on Schedule II hereto;
- (c) all of Releasee's Copyrights and Copyright Licenses to which it is a party;
- (d) all reissues, continuations or extensions of the foregoing;

(e) all goodwill of the business connected with the use of, and symbolized by, each Patent, each Patent License, each Trademark, each Trademark License, each Copyright and each Copyright License; and

(f) all products and proceeds of the foregoing, including, without limitation, any claim by Releasee against third parties for past, present or future (i) infringement or dilution of any Patent or Patent licensed under any Patent License, (ii) injury to the goodwill associated with any Patent or Patent licensed under any Patent License, (iii) infringement or dilution of any Trademark or Trademark licensed under any Trademark License, (iv) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License, (v) infringement or dilution of any Copyright or Copyright licensed under any Copyright License, and (vi) injury to the goodwill associated with any Copyright or Copyright licensed under any Copyright License.

WHEREAS, the Notice of Security Interest in Patents was recorded at the United States Patent and Trademark Office at Reel 18193/Frame 0722-0732 on August 31, 2006;

WHEREAS, the Notice of Security Interest in Trademarks was recorded at the United States Patent and Trademark Office at Reel 3380/Frame0454 on August 30, 2006.

WHEREAS, Releasee has requested that Releasor release and discharge fully the Security Interest; and

WHEREAS, Releasor is willing to release and discharge fully the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully the Security Interest, and all other right, title and interest in and to the Intellectual Property Collateral conveyed to Releasor by Borrowers or Releasee (if any) pursuant to the IP Security Agreement, the Security Agreement, the Credit Agreement and associated Loan Documentation, and Releasor hereby reassigns any and all such right, title and interest that it may have in the Intellectual Property Collateral (if any) to Releasee. Releasor further agrees to execute and deliver to Releasee, at Releasee's expense, any and all further documents or instruments and do any and all further acts which Releasee (or its agents or designees) reasonably requests in order to confirm Releasee's rights in and to the Intellectual Property Collateral.

IN WITNESS WHEREOF, Releasor has caused this Release to be duly executed by its officer thereunto duly authorized as of the 3rd day of March, 2010, which shall be effective for all purposes as of the 2nd day of February, 2010.



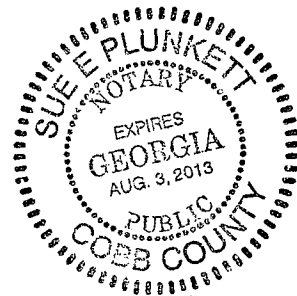
