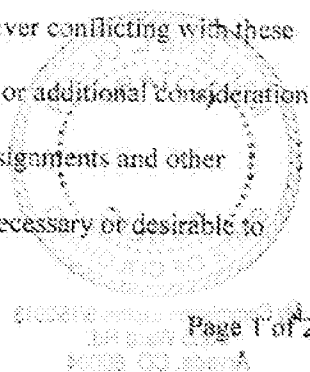
ASSIGNMENT
