## PATENT ASSIGNMENT

Assignor further covenants and agrees that it will communicate to Assignee, its successors, legal representatives and assigns, any facts known to it respecting the invention covered by the Patent, and testify in any legal proceeding, sign all lawful papers, make all rightful oaths, and generally do, at the request of Assignee, all lawful and just acts to aid Assignee, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention covered by the Patent in the United States of America, including obtaining the cooperation and assistance of the inventors of the Patent to do all the foregoing acts.
