

RELEASE OF PATENT SECURITY INTEREST, dated as of March 20, 2012 (this "**Release**"), by CREDIT SUISSE AG, as Collateral Agent (as defined below) in favor of Metal Services Holdco LLC, Tube City IMS Corporation (as successor-in-interest to Metal Services Merger Sub Corp.) and Tube City IMS, LLC (successor-in-interest to International Mill Service, Inc. and Tube City, LLC). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Term Loan Credit Agreement dated as of January 25, 2007 (as amended, supplemented or otherwise modified from time to time prior to the date hereof, the "**Credit Agreement**"), among METAL SERVICES HOLDCO LLC, a Delaware limited liability company ("**Holdings**"), TUBE CITY IMS CORPORATION (as successor-in-interest to Metal Services Merger Sub Corp.), a Delaware corporation (the "**Borrower**"), the subsidiaries of the Borrower from time to time party thereto, the lenders from time to time party thereto (the "**Lenders**") and CREDIT SUISSE AG, as administrative agent (in such capacity, the "**Administrative Agent**") for the Lenders and as collateral agent (in such capacity, the "**Collateral Agent**"), (ii) the Pledge and Security Agreement dated as of January 25, 2007 (as amended, supplemented or otherwise modified from time to time prior to the date hereof, the "**Security Agreement**"), among Holdings, the Borrower, the subsidiaries of the Borrower from time to time party thereto, the Collateral Agent and the Administrative Agent, and (iii) the Patent Security Agreement dated as of January 25, 2007 (the "**Patent Security Agreement**"), among Holdings, the Borrower, the subsidiaries of the Borrower party thereto (collectively, the "**Grantors**") and the Collateral Agent (such documents set forth in clauses (ii) and (iii), the "**Collateral Agreements**").

B. Pursuant to the Collateral Agreements, among other things, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the patents of the Grantors set forth on Schedule I hereto (the "**Patents**"), which security interest was recorded with the United States Patent and Trademark Office on February 20, 2007 at Reel/Frame 018904/0398.

D. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Patents granted under the Collateral Agreements.

Accordingly, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, cancel, relinquish and discharge any and all security interests it has against the Patents and reassigns all right, title and interest it has, if any, in the Patents to the

applicable Grantor. The Collateral Agent agrees to make filings with the United States Patent and Trademark Office and take further actions, in each case as reasonably requested by the Grantors and at the sole expense of the Grantors, to evidence the release and termination of the Collateral Agent's security interests in the Patents. Except as provided in the Collateral Agreements, the execution and delivery of this release and any further documents and the performance of any actions by the Collateral Agent are made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
