**WHEREAS**, ALCATEL LUCENT, a corporation organized under the laws of France ("Alcatel-Lucent"), having a principal business address at 3 avenue Octave Gréard, 75007, Paris, France, and a successor in interest of former Alcatel S.A., prior to the Effective Date (as defined herein below) of this Patent Assignment (the "Assignment"), is the owner of record of the Transferred Patent as follows:

**WHEREAS**, COMMSCOPE, INC. OF NORTH CAROLINA ("CommScope"), a North Carolina Corporation, having offices at 1100 CommScope Place SE, Hickory, North Carolina 28602 is desirous of acquiring the entire interest in and to the Transferred Patent (as identified herein above);

**WHEREAS**, Alcatel-Lucent and CommScope have entered into a Patent Transfer Agreement for the Transferred Patent dated 20 March, 2012, (the "Patent Agreement") wherein Alcatel-Lucent has agreed to the transfer of the Transferred Patent subject to the terms of that Patent Agreement;

**NOW, THEREFORE**, to all whom it may concern, be it known that for good and valuable consideration to Alcatel-Lucent ("Assignor"), the receipt, adequacy, and sufficiency of which is hereby acknowledged, Alcatel-Lucent has assigned, transferred, and set over, and by these presents does assign, transfer, and set over unto CommScope ("Assignee"), subject to all existing rights and licenses of third parties, including the license grant to Alcatel-Lucent set out in the Patent Agreement, its whole right, title, and interest in and to all of the Transferred Patent, said whole right, title, and interest in and to said Transferred Patent including all past, present, and future causes of action and claims for damages derived by reason of patent infringement thereof (to the extent such damages are not already paid, awarded or contractually owed to Alcatel-Lucent, its Related Companies or any predecessor of Alcatel-Lucent or Alcatel-Lucent's Related Companies), for CommScope's own use and for the use of its assigns, successors, and legal representatives to the full end of the term of the Transferred Patent. For clarity, the foregoing assignment does not include (i) any trademarks, trade dress, trade names, or other indicia of origin; (ii) except for inventions of the Transferred Patent, any inventions or discoveries, whether patentable or not, and registrations, invention disclosures, patents and applications therefore; (iii) any trade secrets, confidential information or know-how; (iv) any works of authorship, whether copyrightable or not; and (v) any other intellectual property or proprietary rights of Alcatel-Lucent, its Related Companies or any predecessor of Alcatel-Lucent or Alcatel-Lucent's Related Companies.

Alcatel-Lucent, for itself, and its heirs, assigns, and legal representatives hereby further covenants to and with CommScope, its assigns, successors, and legal representatives to fully cooperate therewith in perfecting this Assignment in the United States, said cooperation extending to the Transferred Patent, and including the execution of additional assignments or other formal documents as may be required in connection therewith, but in all such cases shall be at the expense of CommScope.

#### DEFINITIONS

**Effective Date** herein shall mean 20 MARCH 2012.

**Related Companies** means (i) with respect to CommScope, CommScope, Inc.'s Subsidiaries; (ii) with respect to Alcatel-Lucent, its Subsidiaries; and (iii) any other company so designated in writing signed by Alcatel-Lucent and CommScope.

**Subsidiary** of a company means a corporation or other legal entity (i) the majority of whose shares or other securities entitled to vote for election of directors (or other managing authority) is now or hereafter controlled by such company either directly or indirectly; or (ii) which does not have outstanding shares or securities but the majority of whose ownership interest representing the right to manage such corporation or other legal entity is now or hereafter owned and controlled by such company either directly or indirectly; but any such corporation or other legal entity shall be deemed to be a Subsidiary of such company only as long as such control or ownership and control exists.
