Assignor hereby authorizes an attorney of the Assignee to prosecute Provisional Application No. 60/739,818, filed November 23, 2005.

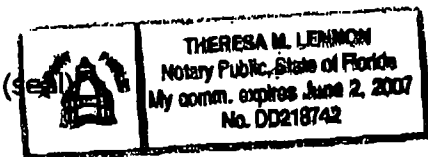

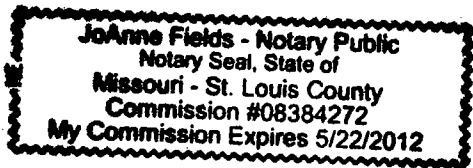
