substitute, continuation, and Convention applications based in whole or in part upon  
said inventions or discoveries, or upon said applications, and any and all Letters  
Patent, reissues, and extensions of letters Patent granted for said inventions and  
discoveries or upon said applications, and every priority right that is or may be  
predicated upon or arise from said inventions, said discoveries, said applications, and  
said Letters Patent.



Bind our heirs, legal representatives, and assigns, as well as ourselves, to do, upon the Assignee's request and at the Assignee's expense, but without additional consideration to us or them, all acts reasonably serving to assure that the said inventions and discoveries, the said patent applications, and the said Letters Patent shall be held and enjoyed by the Assignee as fully and entirely as the same could have been held and enjoyed by us, our heirs, legal representatives, and assigns if this assignment had not been made; and particularly to execute and deliver to the Assignee all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by the Assignee; to communicate to the Assignee all facts known to us relating to said inventions and discoveries or the history thereof; and to furnish the Assignee with any and all documents, photographs, models, samples, and other physical exhibits in our control or in the control of our heirs, legal representatives, or assigns which may be useful for establishing the facts of our conceptions, disclosures, and reduction to practice of said inventions and discoveries.




