**Under Section 904 of the New York Business Corporation Law**

It is hereby certified, as of February 28, 2011, on behalf of the corporations named herein, as follows:

**FIRST:** The name of the merging corporation to be merged, which was organized under the laws of the State of Delaware, the certificate of incorporation having been filed with the Secretary of State of the State of Delaware on June 8, 1992, is Muller Martini Mailroom Systems, Inc., a Delaware corporation. The Application for Authority in the State of New York of said corporation to transact business as a foreign corporation therein was filed with the Department of State of the State of New York on June 14, 1996.

**SECOND:** The name of the surviving corporation, which was organized under the laws of the State of New York on March 1, 1967, is Muller Martini Corp., and was originally formed under the name Graphequip Corporation.

**THIRD:** The Board of Directors of each of the constituent corporations party to the merger provided for hereunder each has duly authorized the Agreement and Plan of Merger between the constituent corporations, setting forth the terms and conditions of the merger provided for herein.

**FOURTH:** The merger herein certified is permitted by the laws of the jurisdiction of incorporation of the merging corporation and is in compliance with said laws.

**FIFTH:** The designation and number of outstanding shares of the merging corporation, all of which shall be cancelled following the merger, as set forth in the agreement and plan of merger, are as follows:
