AND I hereby covenant and agree that I will communicate to said Assignee or nominee all facts known to me pertaining to said inventions, and testify in all legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and declarations and in general perform all lawful acts necessary or proper to aid said Assignee or nominee in obtaining, maintaining and enforcing all lawful patent protection for said inventions anywhere in the world.


