ASSIGNMENT

AND I hereby covenant and agree for myself, my heirs, and my legal representatives, to assist the said assignee in the prosecution of said application and in any interference which may arise involving said invention, and, upon request, to execute without further consideration all necessary and desirable divisional, continuing, renewal, reissue, or other applications for patents in any country, that might be deemed necessary by said assignee fully to secure to said assignee its interest as aforesaid in and to said invention or any part thereof, and in and to said several patents or any of them.

AND I do hereby authorize and request the Commissioner of Patent and Trademarks of the United States of America to issue any and all United States patents which may be granted upon said United States applications or any of them, or upon said invention or any part thereof, to said corporation.

THIS ASSIGNMENT shall be effective *nunc pro tunc* as of August 17, 2001.
