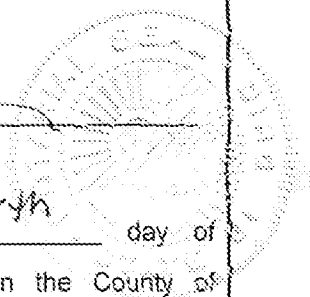
ASSIGNMENT



NOW, THEREFORE, to all whom it may concern, be it known that for and in consideration of the premises and other valuable considerations, We, John P Clark, Jamie J Johnson, Michael K Ooten, have sold, assigned, and transferred, and by these presents do sell, assign, and transfer unto the Government of the United States, as represented by the Secretary of the Air Force, our entire right, title and interest throughout the world in and to the aforesaid joint invention described in the aforesaid application for Letters Patent of the United States, and any and all applications for patent and patents in any and all countries foreign to the United States, and all Letters Patent issuing thereon and any continuations, continuations-in-part, divisions, and reissues or extensions thereof; and all priority resulting from the filing of the aforesaid application for patent in the United States; We hereby authorize and request any official whose duty it is to issue patents to issue any patent thereon to the United States of America, as represented by the Secretary of the Air Force, and his successors, as assignee of our entire right, title and interest in and to the same, for the sole use for the full term or terms for which said patents and any continuations, continuations-in-part, divisions and reissues or extensions thereof are, or may be, granted as fully and entirely as the same would have been held by us had this Assignment not been made; and We do hereby also grant to the Government of the United States as represented by the Secretary of the Air Force, the option to take the entire right, title and interest in the invention or all applications for Letters Patent thereon in all countries foreign to the United States in which the United States of America may file, or cause to be filed, applications for Letters Patent, without payment to us of any further consideration; provided, however, that this grant of an option to take foreign rights in the invention must be exercised by written notice to us within eight months of the filing date of any application for United States Letters Patent covering the invention, or within eight months from the declassification of the invention, whichever is later, and that all foreign rights not exercised under the option are left to us subject to a nonexclusive, irrevocable, royalty-free license to the United States of America in any patent which may issue on said invention in any foreign country, including the power to issue sublicenses for use in behalf of the United States of America and/or in furtherance of the foreign policies of the United States of America; and I hereby agree to execute any and all applications for Letters Patent, and to furnish all data and documents and to execute any papers which may be necessary or convenient for the preparation, filing, or prosecution of such applications, except it is understood that We shall not be subject to any out-of-pocket expense relative to such action.




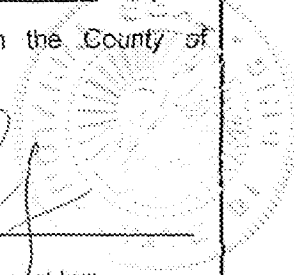


