RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Agreement"), effective as April 4, 2012, is made by Zions First National Bank (the "Secured Party") in favor of the Borrower (as defined in that certain Security Agreement by and between NACO Industries, Inc. and Webbank Corporation dated as of April 22, 1999 (as amended, supplemented or otherwise modified from time to time, (the "Security Agreement")). All terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, the Borrower granted to Webbank a security interest in all of Borrower's Intellectual Property as recited in the Agreement.

WHEREAS, pursuant to an Assignment of Loan dated May 17, 2005, Webbank assigned all of its rights, title and interest to the subject loan to Secured Party.

WHEREAS, pursuant to an Assignment of Assignors Interest dated May 17, 2005 and recorded with the U.S. Patent and Trademark Office on June 1, 2005, Webbank granted to Secured Party a security interest in and to Patents No. 4708374 and 5597185 (hereinafter referred to as the "Intellectual Property") as recited in the Assignment.

WHEREAS, the Secured Party therefore desires now to release its security interest in and to the Intellectual Property.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party agrees as follow:

SECTION 1. Release of Security Interest. The Secured Party hereby releases all of its rights, title and interest in and to the Intellectual Property.

The Secured Party shall at its expense, timely take, or cause to be taken, all appropriate action, do or cause to be done all things necessary, proper or advisable under applicable law, execute and deliver any additional documents and other papers, and perform such additional acts that may be necessary or desirable to carry out the provision of this Agreement and consummate and make effective the transaction contemplated herein.


