CONFIRMATORY ASSIGNMENT**



AND, Assignor hereby warrants and covenants that Assignor has not and will not execute any assignment or other instrument in conflict with this assignment;

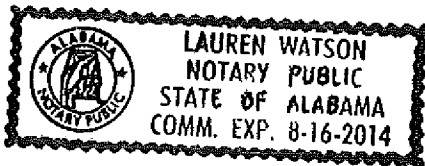
