ASSIGNMENT

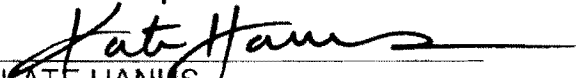

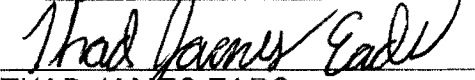
