PATENT ASSIGNMENT NUNC PRO TUNC

This Patent Assignment Nunc Pro Tunc ("Assignment") is made on the date of the first signature below, to be effective as of December 31, 2008 nunc pro tunc, by ALAN D. This Assignment is made with reference to the following facts:



Assignor covenants and agrees that he will at any time on request, and at Assignee's own sole cost and expense, execute and deliver to Assignee any and all documents and papers as may be necessary to perfect in Assignee the interests herein conveyed, and further covenants and agrees that he will communicate and cooperate with Assignee to the extent necessary for Assignee to have and enjoy to the fullest extent the interests herein conveyed.
