SUBSTITUTED PYRAZOLO-QUINAZOLINE DERIVATIVES AS KINASE INHIBITORS

for which an application Serial No. 13/327,979 (Docket No. P4588) for Letters Patent has been filed by them on December 16, 2011, which application claims the benefit of Serial No. EP patent no. 10195675.3 filed December 17, 2010; and




