ASSIGNMENT

Assignor hereby irrevocably assigns, transfers and conveys to Assignee, its successors, legal representative, and assigns all of its right, title and interest in and to the above mentioned Assigned Assets, and all other common law or statutory rights, claims and privileges pertaining to, arising out of or associated with, the Assigned Assets, including, without limitation, the right to the underlying inventions, the right to file, prosecute and maintain the Assigned Assets in the United States of America or other countries, and the right to sue, seek equitable relief and recover damages for past, present and future infringement thereof, as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment not been made.

2. Further Assignment

Assignor further assigns to and empowers Assignee, its successors, assigns or nominees, all rights to make applications for patents, receive patents or other forms of protection for said inventions and to prosecute such applications and patents arising therefrom, as well as to claim and receive the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention or treaty which may henceforth be substituted for it, and the right to invoke and claim such right of priority without further written or oral authorization, as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment not been made.


