AND WE HEREBY covenant and agree that we will communicate to said ASSIGNEE, its successors, legal representatives, and assigns any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue, and other related applications, make all rightful oaths and generally do everything possible to aid said ASSIGNEE, its successors, legal representatives, and assigns, in obtaining and enforcing proper patent protection for said improvements in all countries.


