PATENT SECURITY RELEASE AGREEMENT

WHEREAS, pursuant to those certain Patent Security Agreements and other related financing documents (the "*Patent Security Agreements*"), D-M-E Company, Inc., a Delaware corporation, located at 2911 Stephenson Highway, Madison heights, MI 48071, D-M-E U.S.A. Inc., a Michigan corporation, located at 2911 Stephenson Highway, Madison heights, MI 48071, Milacron Inc., a Delaware corporation, located at 4165 Half Acre Rd., Batavia, OH 45103, Milacron Industrial Products Inc., a Michigan corporation, located at 1160 White Street, Sturgis, MI 49091, Oak International, Inc., a Michigan corporation, located at 1160 White St., Sturgis, MI 49091, Uniloy Milacron Inc., a Delaware corporation, located at 5550 Occidental highway, Tecumseh, MI 49286, and Uniloy Milacron U.S.A. Inc., a Michigan corporation, located at 10495 Highway M52, Manchester, MI 48158 (each referred to individually as a "*Company*" and, collectively, as the "*Companies*") have granted to Agent a security interest in certain patents owned by the Companies, including but not limited to the patents set forth in Schedule 1A (all such patents collectively referred to herein as the "*Patents*"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby releases any and all claims, liens, and other encumbrances in and to the Patents and reassigns any and all rights, titles and interests therein, without any representation, recourse or undertaking by Agent, to the applicable Company.
