This Assignment is effective as of the respective filing date(s) set forth above.

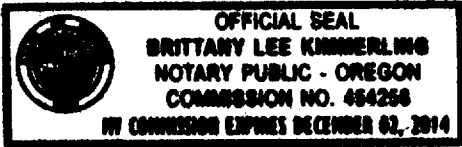
