

AND we do hereby request and authorize the Commissioner of Patents, United States of America, to issue said Letters Patent when granted, in accordance with this assignment.

We further covenant and agree with the ASSIGNEE that we have a full and unencumbered title to the design herein assigned, which title we warrant unto the ASSIGNEE, and we, the undersigned ASSIGNORS, further agree that we will, without demanding any further consideration therefor, at the request but at the expense of the ASSIGNEE, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining, sustaining or reissuing United States or foreign Letters Patent for the said design, and for maintaining and perfecting the ASSIGNEE'S right to said design and Letters Patent in all countries, particularly in cases of litigation.






