- (d) the exclusive right to bring or participate in any proceeding for past infringement or any other actionable right under all of the foregoing and to receive all remedies that arise therefrom, to the end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by us had this Assignment not been made.

Further, Assignor agrees that Assignor will communicate to the Assignee or its representatives any facts known to us respecting the invention, and testify in any legal proceeding, sign all


