Assignment of Patent Rights

- (1) FIL International Limited
- (2) Filtrona C&SP Limited

Dated 14 MARCH 2012

This Agreement is made on

Between:

- (1) **FIL International Limited** whose principle office is at 201-249 Avebury Boulevard, Milton Keynes MK9 1AU (the "**Assignor**"); and
- (2) **Filtrona C&SP Limited** whose principle office is at Giltway, Giltbrook, Nottingham NG16 2GT (the "**Assignee**").

Background:

- (A) The Assignor is the proprietor of the Patent Rights (defined below).
- (B) The Assignor has agreed to assign the Patent Rights to the Assignee as part of an intra group transfer on the terms specified below.

It is agreed as follows:

1. Definitions and interpretation

- 1.1 In this Agreement, unless the context otherwise requires, the following definitions shall apply:

"Agreement" means this Agreement (including any schedule or annexure to it and any document in agreed form).

"Patent Rights" means the patents and patent applications details of which are set out in Schedule 1 to this Agreement including all patents that may be granted pursuant to any such applications, as well as all patents that may derive priority from or have equivalent claims to or be based on the patents and patent applications set out in Schedule 1 in any country in the world.

2. Assignment

- 2.1 In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor acknowledges) the Assignor with full title guarantee assigns to the Assignee for the full period including any renewals and extensions:

- (a) all its right, title and interest in the Patent Rights;
- (b) the right to be granted a patent on the Patent Rights;
- (c) the right to claim priority from the Patent Rights in respect of any further patent application in any country of the world, and the right to be granted a patent on such further patent right; and
- (d) all rights of action, powers and benefits arising from ownership of the Patent Rights throughout the world, including the right to sue for damages and other

legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to, on or after the date of this Agreement.

3. Further assurance

- 3.1 The Assignor will at the request and expense of the Assignee execute such further documents as may reasonably be required to do any or all of the following:
- (a) vest in the Assignee the rights title and interests expressed to be assigned by clause 2; and
 - (b) defeat any challenge to the validity of and resolve any questions concerning the Patent Rights;
 - (c) register the Assignee as proprietor of the Patent Rights (if applicable);
- 3.2 The Assignor hereby irrevocably appoints the Assignee as its attorney in its name to execute any document and do any act or thing which may be necessary to comply with the provisions of clause 3.1.

4. Entire Agreement

- 4.1 This Agreement sets out the entire agreement and understanding between the parties in respect of the subject matter of this Agreement.
- 4.2 The Assignee acknowledges that it has entered into this Agreement in reliance only upon the representations, warranties and promises specifically contained or incorporated in this Agreement and save as expressly set out in this Agreement, the Assignor shall have no liability in respect of any other representation, warranty or promise made prior to the date of this Agreement unless it was made fraudulently.

5. Variation

No variation of this Agreement is permitted nor shall any variation be effective unless it is in writing and signed by an authorised representative of each of the parties.

6. Exclusion of third party rights

Unless expressly provided in this Agreement, no term of this Agreement is enforceable pursuant to the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to it.

7. Governing law and jurisdiction

- 7.1 This Agreement shall be governed by and construed in accordance with English law.
- 7.2 Each of the parties irrevocably submits for all purposes in connection with this Agreement to the exclusive jurisdiction of the courts of England.
