ASSIGNMENT

WHEREAS, I, **Scott Fletcher**, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **CHAIR WITH CURVED LEGS AND BACK SUPPORT**, which application was filed with the United States Patent and Trademark Office on March 5, 2012 as Application Serial No. 29/414,869.

AND WHEREAS, **VIRCO MFG. AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, an agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
