- (d) to make and maintain for the Company adequate and current written records of such inventions, discoveries, improvements, trade secrets, compilations, mask works and works of authorship,
- (e) upon any termination of my employment to deliver to the Company all papers, records, data or plans generated by me or others for the Company,
- (f) not to use, publish or otherwise disclose (except as my Company duties may require), either during or subsequent to my employment, any secret or confidential information or data of the Company or any information or data of others which the Company is obligated to maintain in confidence,
- (g) and not to disclose or utilize in my work for the Company any secret or confidential information of others (including any prior employees), or any inventions, discoveries, improvements, trade secrets, compilations, mask works, or works of authorship of my own which are not included within paragraph (a) of this Agreement,
