The ASSIGNOR hereby undertake without liability at any time upon request to do everything legally possible to assist the ASSIGNEE in the filing and prosecution of any patent application relating to the invention in any country, to sign such documents and do such things as may be required to give effective legal and registered title of the ASSIGNEE to the invention in any country, all without further consideration but at the expense of the ASSIGNEE.

This Assignment shall enure to the benefit of, and be binding upon, the ASSIGNOR, and the ASSIGNEE and their respective heirs, executors, legal personal representatives, successors and assigns.
